President's Comments – Volunteers at the shows did an excellent job. Pin costs increased after several years of being the same; so sale price was increased for the shows. Square fees increased a little, 2.6% now. Dues notices have been mailed.

Communication — TSA offering a \$20K signing bonus for a Nantucket position. Maine had a 72-hour waiting period to buy a gun and it has been thrown out by the court. Beacon Hill Senators and Reps have a \$82,046 base pay with stipends of \$119,000 for the House Speaker and Senate President! Other leadership positions get \$22K to \$96K. VIP Ticket package for Huntstock will be added to the Annual Raffle. Three positions were cut from CCNS by D.O.G.E.

Legislation - Working on the Watch List. Committees have been assigned. Still waiting on Bill Numbers.

Hunter Ed / Fisheries & Wildlife – Instructors received their annual thank you package. EPO's will not respond to Dead Bird calls. Stop driving on thin ice; EPO's are tried of pulling you out. Currently there are Six in-person courses and eleven blended courses for Basic Education.

Ware River Watershed – DCR says a review of the Access Plan will happen this spring. To happen every other year. Forest restoration for baron's habitat in Rutland (tree harvest and prescribed burns). Prison Camp tunnel was collapsed and filled in to prevent any possible injuries. Cameras have caught people doing graffiti and they will be prosecuted.

Quabbin Watershed Advisory - No update.

Marine Fisheries – Hearing scheduled on March 11th at Mass Maritime on multiple categories (Striped Bass, Menhaden, Groundfish, Summer Flounder, Conch Pots, American Eel, Dogfish Fins, and Entanglement Reporting, False Albacore, Atlantic Bonito, Shark and Shore-Based Fishing, Black Sea Bass, and Non-Native Worms). Safe Boating Act was passed and has no grand fathering.

Forrest and Parks - Some plans for habitat restoration it the works.

Deer/Bear Damage Report – Additional Bear information/vote in March or April due to a glitch. Deer changes passed.
