Roll Call - quorum

**President's Comments** - Jack Coughlin is still in the hospital after his accident. There is a GOFUNDME account to help Jack come home - <a href="https://gofund.me/cdf716a0">https://gofund.me/cdf716a0</a>. Instead of Earth Day in Agawam it will be Jack Coughlin Appreciation Day. The Medina Street Boat Ramp in Chicopee might be renamed in his honor. (post script: Jack passed away on April 18). F&W Board on April 23<sup>rd</sup>. The Migratory Bird Hearing will be before the monthly meeting.

Communication - A new Rasmussen Survey (March 2021) may have just provided a needle to pop their bubble as a majority of "likely U.S. voters say it is not possible to completely prevent mass shootings like the ones in" Atlanta and Boulder. The specific question of whether stricter gun control laws would help prevent mass shootings", 51% of voters say no, 39% say yes. The Pennsylvania Game Commission has given preliminary approval to expand Sunday hunting in 2021. We received the 2020 Division of Ecological Restoration annual report. Fake ammunition scammers are posing as online retail storefronts and aiming to steal your cash and personal information with too-good-to-be-true ammo deals and offers. In March 2021 there were pistols, over 1.1 million, with about 670,000 rifles, the remainder being classified as other and multiple sales. This is down 20% from March 2020. Types Of Guns Used In Mass Public Shootings 1998 Through March 2021: Handgun 55%, Rifle only (including AR and AK) 11%, Shotgun 4%. Combination of firearms 30%. This count was reported by the Crime Prevention Research Center. VT has Bill S.129, and it would legislate anti-hunters onto the Fish and Wildlife Board. It removes the current system in favor of a system that allows legislators to appoint a full 2/3 of a new board that would be established.

**Legislation** - There are only a few bill numbers posted. 2377 bills in the Senate, reviewed 44. 4476 House bills and 90 pulled out for review. A report saying bills may be acted on without hearings. The Legislative Watch List has been posted to our website. House Budget due for release this week. There are plenty of complaints about the state House being closed. Trapping bills in VT and NY. In Woodstock, CT the beaver problem is increasing. The NIP bottle bill now has 31 sponsors. The updated Watch List has been posted to the web site.

**Hunter Ed** – Secretary Bernard was a volunteer instructor at multiple Basic Hunter Ed field days in March. The F&W Team has done a great job for doing courses. During the 3 days I was there about 120. The totally online course is under review.

The NWTF learn to hunt course for adults was held last weekend, the course filled up in 24 hours. Youth Day course is online.

The MA Bear Biologist Dave Wattles said he had little information about bear damage on farms. The report was sent to him. It would be nice to have an open bear season from the beginning of archery to the close of Muzzleloader.
