Marine Fisheries – The state's commercial conch pot season is scheduled to open April 15, 2022. While this generally authorizes the use of conch pot gear within state-waters, there are two overarching state and federal trap gear closures to protect right whales that apply.

Due to unavoidable delays in processing some trap tag orders, 2021 trap tags for all trap types (i.e., lobster trap, fish pot, and conch pot) will remain valid through May 31, 2022.

NOAA Fisheries is proposing a federal closure on recreational scup harvest in 2022. This closure would apply to all recreational vessels fishing in federal waters and all for-hire vessels holding a federal scup permit fishing in either state or federal waters.
